GRANTING TO CONSTRUCT, INSTALL, AND MAINTAIN A SECURITY ENTRANCE GATE OVER A PORTION OF THE RIGHT-OF-WAY OF HALLWOOD DRIVE

Be it ordained by the Council of the City of Montgomery, Alabama:

1. That a license containing the hereinafter prescribed terms and conditions be, and the same hereby is granted unto Thorington Trace Homeowners Association, and their successors and assigns, in the ownership of the parcel hereinafter described to allow construction, installation, maintenance, and use of the following:
