**GRANTING TO CONSTRUCT, INSTALL, AND MAINTAIN A SECURITY
ENTRANCE GATE OVER A PORTION OF THE RIGHT-OF-WAY OF
HALLWOOD DRIVE**

Be it ordained by the Council of the City of Montgomery, Alabama:

1. That a license containing the hereinafter prescribed terms and conditions be, and the same hereby is granted unto Thorington Trace Homeowners Association, and their successors and assigns, in the ownership of the parcel hereinafter described to allow construction, installation, maintenance, and use of the following:

A security entrance gate over and on a portion of the right-of-way of Hallwood Drive owned by the City of Montgomery and described as follows:

Commence at the southwest corner of Lot 42, Block I, Corrected Map of Corrected Map of Thorington Trace Plat No. 2 as recorded in the Office of the Judge of Probate of Montgomery County, Alabama in Plat Book 46 Page 133; thence run along the south line of said Lot 42, along a curve concave to the north (Radius 300.00 feet) a chord of North 76°-48'-39" East, 50.57 feet to the Point of Beginning; thence from said point of beginning, continue along the south line of said Lot 42, along a curve concave to the north (Radius 300.00 feet) a chord of North 71°-01'-05" East, 10.02 feet; thence South 22°-57'-25" East, 113.87 feet to the north line of Lot 15, Block R, Thorington Trace Plat No. 4 as recorded in the Office of the Judge of Probate of Montgomery County, Alabama in Plat Book 49 Page 25; thence run along the north line of said Lot 15, along a curve concave to the north (Radius 437.47 feet) a chord of South 62°-25'-19" West, 10.03 feet; thence North 22°-57'-25" West, 115.38 feet to the point of beginning.

2. By accepting this permit, the aforesaid Thorington Trace Homeowners Association, and their successors and assigns (hereinafter collectively referred to as "Licensee"), in interest in the above described parcel, does assume and agree to be bound by the several duties and obligations imposed upon them by the following terms and conditions of this License, namely:
 - a. The City authorizes and permits the Licensee to construct, operate and maintain security entrance gate within the right-of-way previously described in accordance with, and subject to the terms of this License.
 - b. Upon allowing construction of security entrance gate, no liability will attach to the City of Montgomery from its existence, use or maintenance, and the Licensee has agreed to indemnify and hold harmless the City of Montgomery from any and all liability arising from the construction, maintenance or use of said security entrance gate.

- c. The above described security entrance gate will be allowed to remain upon the written approval by the City Building Inspector and the City Engineer.
 - d. No other construction of any type will be built under the terms of this License.
 - e. The City of Montgomery shall have authority to enter upon said right-of-way for the maintenance and repair of its facilities located therein.
 - f. Licensee is to remove said security entrance gate any time upon 30 days written notice from the City and agrees to remove said security entrance gate at no expense to the City should notice be given; and in the absence of the Licensee's compliance with such request to remove said security entrance gate, the City is hereby authorized to remove said security entrance gate at the expense of the Licensee.
 - g. Should the City determine that it is necessary to enlarge or reconstruct or improve the street or any facility located in said right-of-way, the City shall be held harmless should such enlargement, reconstruction, or improvement damage or injure any physical property, including the security entrance gate.
 - h. This License shall expire at the end of thirty (30) years.
3. That the Mayor and the City Clerk be, and are hereby authorized and directed to execute and attest, respectively, for and on behalf of the City of Montgomery, Alabama the "License Agreement" containing the above terms.

WHEREAS, the Department of Justice, Bureau of Justice Assistance, has made funding for law enforcement activities available through the FY2021 Justice Assistance Grant (JAG), for which the Montgomery Police Department seeks to make application; and

WHEREAS, the City of Montgomery is of the opinion it would be beneficial to make application for such assistance in the amount of \$114,129.00, 100% federal funds for specific projects carrying no match fund requirement. These funds will be divided between the Montgomery Police Department and Montgomery County Sheriff's Office. The Montgomery Police Department will receive \$68,477.40. This amount of \$68,477.40 will be used for the purchase of a DVR and analytic software for Montgomery Police Department use.
