SUBJECT: Request for approval of trim and siding material for the property located at 1112 Felder Avenue (Old Cloverdale).

REMARKS: The petitioner is requesting permission to install a cementitious lap siding on the chimney, which required the existing sheathing to be removed for repairs; and on painted plywood used to fill the eave overhang on the front gable. The lap on the plywood will match the existing lap siding reveal, the chimney will utilize the full reveal of the cementitious siding (see photo for partially installed siding), which is wider than the lap of the existing siding and will not match the lap of the siding on the house. The chimney will retain the corner boards.

The petitioner is also requesting permission to replace the existing 2" brick mold window surrounds with a grooved/fluted 3 ¼ inch trim, and to extend the trim over the front porch by abutting the same 3 ¼ inch trim next to the 3 ½ inch plain trim board. The corners will be mitered (no decorative corner pieces are proposed).

The house will also be repainted with colors from the pre-approved palette, no approval is required.

STANDARD OF REVIEW: Section 15-127 of the City Code states that "The board shall approve an application and issue a certificate of appropriateness if it finds that the proposed change, erection or demolition conforms to the general design standards established by the board, is compatible with the character of the historic property or historic district and does not materially impair the architectural or historic value of the historic property or historic district."
