### 2. PRESENTED BY: Paula & Randy Clark

**SUBJECT**: Request approval of a Historic Plaque for the property located at 1960/1962/1964 Ridge Avenue (Old Cloverdale).

**REMARKS:** Two story brick neoclassical revival house; symmetrical façade, end gable shingle roof; end chimneys; 6:6 windows, round columns, sunroom (likely original enclosure) with 2<sup>nd</sup> floor walkout; small addition to the rear; 2<sup>nd</sup> floor entry at north elevation rear; half round gable vents; 2 bay hipped roof brick garage. Original front entry modified—since the width of the entry accommodates two doors, the original configuration was likely a wide door with sidelights, the fanlight above the doors has also been filled in.

According to the owner, the house was built as a single family house and divided during the Depression. The first floor was split into two units, and the upper floor was a single unit occupied by the owners.

According to Montgomery County Tax Records, the house was built in 1910. They would like the sign to read "Old Cloverdale, 1910".

**COMMENTS:** A Historic Building sign is granted in cases where properties have had relatively few changes in materials or appearance since their construction.
