BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MONTGOMERY, ALABAMA as follows:

SECTION 1. That the Zoning Ordinance of Montgomery, Alabama, adopted September 17, 1963, be amended by removing the following described property from an AGR-1 (Residential Agriculture) Zoning District to a PGH-40 (Patio-Garden Home) Zoning District.

KNOW ALL MEN BY THESE PRESENTS, the undersigned, *Tashina Morris / TS Morris Youth Int.* being owner of all of the lands abutting the hereinafter described street, and desiring to vacate and close the same to the public, do hereby declare to be vacated and closed, the following described street in the City of Montgomery, County of Montgomery, Alabama, described as follows:

Beginning at the intersection of the east right-of-way of Greyhound Street and the south right-of-way of McGowan Street, being the northwest corner of Lot 18 according to the Heilpern Subdivision of the Moses Brothers Subdivision of the Pollard Tract, as recorded in the Judge of Probate of Montgomery County, Alabama in Plat Book 5 at Page 73; thence East along the south right-of-way of McGowan Street 113.5 feet to a point; thence North 40 feet to a point on the north right-of-way of McGowan Street; thence West along said north right-of-way 120 feet to the intersection of the north right-of-way of McGowan Street and the east right-of-way of Greyhound Street; thence Southeast 40.5 feet to the Point of Beginning; containing approximately 4, 655 square feet and lying in the northeast quarter of the northeast quarter of Section 14 T16N R17E.

This vacation does not deprive other property owners of such right as they may have to the convenient and reasonable means of ingress and egress to and from their property.

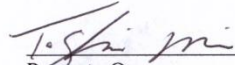

IT IS EXPRESSLY UNDERSTOOD AND AGREED that the grantor, their heirs and assigns, shall not build or erect, nor shall they permit the building or erection of any structure on or over the right-of-way herein conveyed that will interfere with the use of same in any way.

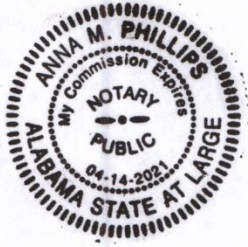

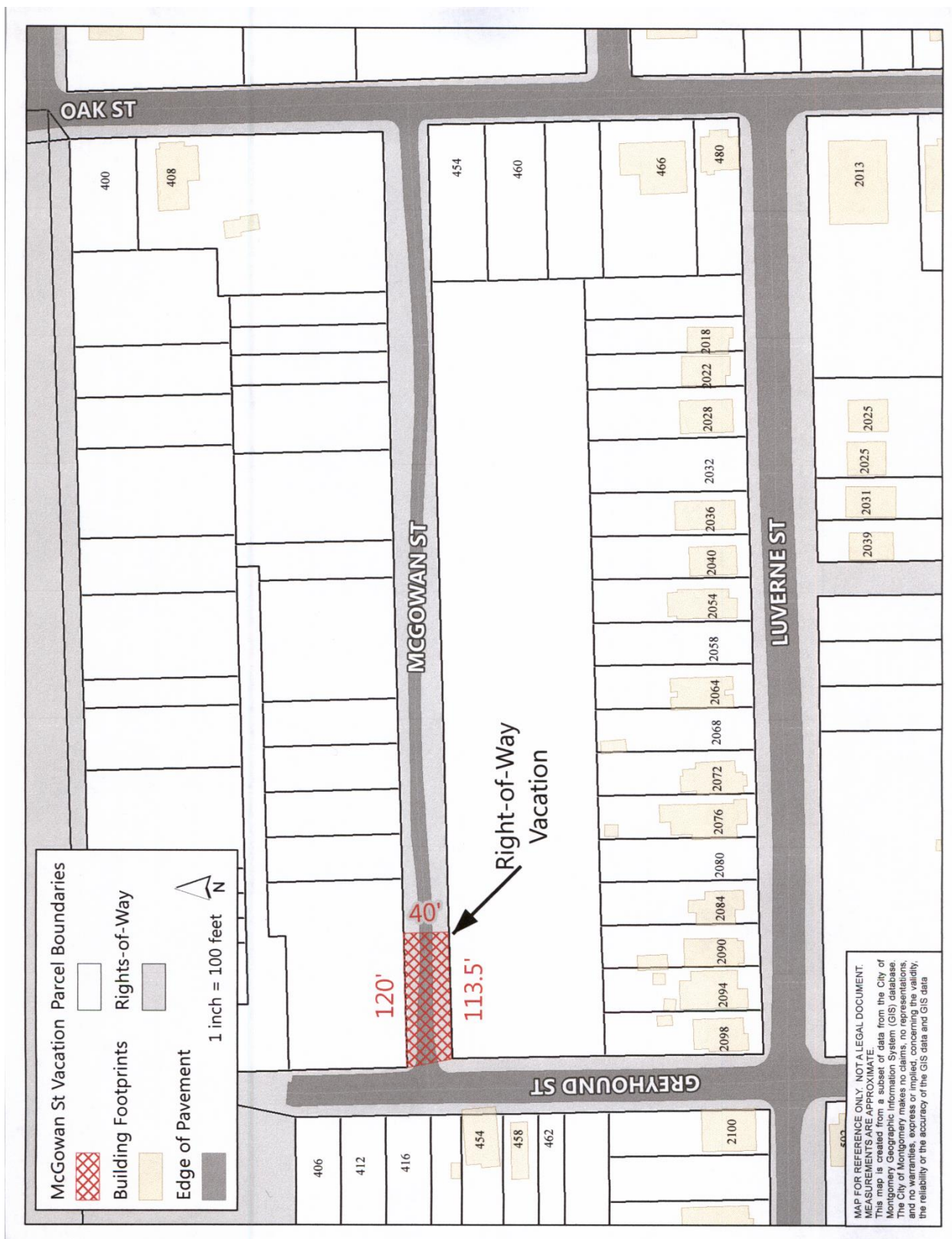
